Terms and Conditions of Entry for Australian Team Selection Trial Number 1 14 December 2014

1. **Members:** Competitors must be paid up Ordinary or Junior Member of MPQ or their respective State or National associations.
2. **Riding Event & Facebook/Youtube Riding Video:** To participate in the Riding Event, Members must:
 - a. have a Riding Certificate (Senior, Novice and Junior Certificates available at; and
 - b. otherwise comply with the UIPM Rules for the Riding Event as far as they are relevant and with any other direction or instruction given by or on behalf of MPQ.
 - c. **VERY IMPORTANT:** *Due to the real ongoing issues of sourcing suitably qualified jumping 1.2m horses, some horse owners have requested that they be able to view videos of the Elite Riders who will be jumping 1.2metres.*
 - d. *Thus, all Elite Riders (those who are jumping 1.2m **AND** competing for selection for the Australian Team) will be required to forward a video of themselves, riding a 1.2m jumping round on a horse of their choice at the venue of their choice, by Sunday the 23rd of November 2014.. Video can be posted to Facebook/Youtube or forwarded directly to organizers so that Horse Owners can visually assure themselves that the riders are a suitable standard and can safely handle the Owners Horses). For example: A rider can get a friend/coach to use a smartphone to video them doing a jumping round and then post the video to Facebook and share it on the MPA Facebook page. Video footage should contain brief introduction (either written or verbal) including riders first name and jumping experience.*
 - e. *Athletes who already have publicly available video of them riding/competing in past Modern Pentathlon events (ie World Cups or Olympic Games) will not be required to forward a video because accessible video footage already exists in a public domain and should forward an email link of the publically available footage to the organizers by 23rd of November 2014.*
 - f. *Due to limited availability of 1.2m elite horses, the organizers reserve the right to allocate the pool of elite horses amongst the elite athletes competing for Australian team selection and then allocate other non 1.2m horses among athletes not vying for team selection. It is expected we will have sufficient elite horses (6) jumping 2 rounds each, for all athletes wishing to jump 1.2m. We will also have several horses that will be capable of jumping 80cm and the organizers reserve the right to allocate these horses to athletes who are not vying for National Team selection. (ie juniors, masters and non-elite athletes)*
3. **Entry Deadline Date/Late Entry:** In order for your entry to be eligible Entry Fees must be received in MPQ's bank account by 7th of December 2014. Acceptance of late entries and payments of entries on the day of competition will be at the sole discretion of the MPQ Management Committee.
4. **Dangerous Activity Acknowledgement/Waiver:** All Competitors (or a parent or guardian for Junior Members) must complete the attached Waiver. Please bring the completed Waiver with you on 7 December 2014.

5. **Withdrawal:** All withdrawals must be notified in writing to event organizers by 12th of December 2014 :
- No refunds will be provided for withdrawals not notified in writing;
 - Entry Fees will be refunded in full to any Competitor whose withdrawal is received by COB on 12th of December 2014; and
 - Entry Fees in respect of Withdrawals received after 12th of December 2014 will not be refunded, except at the sole discretion of the MPQ Management Committee, which may request any further information in respect of the Withdrawal.
6. **Cancellation/Amendment:** MPQ reserves the right to cancel any Event, alter the order or venue, or run any Event in any way it deems fit.
- MPQ Management Committee reserves all rights to cancel the Riding Event at any time prior to 12th December 2014. If this occurs MPQ will refund the portion of the Entry Fee for this event to all Competitors entered for that event;
 - In the event the Competition is cancelled due to events outside the control of MPQ, any refunds will be made at the discretion of MPQ Management Committee and with reference to any unavoidable costs already incurred by, or on behalf of MPQ;
 - No other refunds will be made in respect of any changes to the Schedule, Events or any other aspect of the Competition.
 - Please note that weather in Queensland in December can sometimes deliver in unpredictable severe thunderstorms in the afternoons. The organizers will endeavour to arrange alternative undercover venues for Jumping and the laser shooting component of the Combined Event should there be wet weather. We also have the ability to run the event into the evening under lights should it be necessary.
7. **Transport:** The organizers will assist in providing transport between the swimming venue and the Brookfield Showgrounds (remainder of events).
8. **Course Setup and Practice:** The organizers will be setting up the various discipline venues throughout Saturday the 13th. It is expected that athletes will be able to train/orientate on the various venues after they are setup on the Saturday. Athletes will have to liaise with organizers with respect to training times on the day.
